**Judging** - Monday, July 10<sup>th</sup>, Jetmore Presbyterian Church, 303 W. Best, Jetmore. Judging begins at 5:00 pm

Judging Schedule - is enclosed with this letter. Please arrive at least 15 minutes before your scheduled time.

Script Information Form - You must bring a completed script for the ONE

Buymanship & ONE Construction outfit you will model at the Public Style Show, to
the church on Mon. July 10<sup>th</sup>. Please write descriptions of your outfits to the theme of
'Sow It, Grow It, Show It' - or 150 years of Hodgeman County History - a
Sesquicentennial. Please refrain from using brand names in your description. What you write is what will be read.

**Public Style Show on Friday, July 14<sup>th</sup>, 6:15 p.m.** in the Show Arena. You must attend the Public Style Show to receive ribbons & premium funds, no exceptions.

Purchased Garments Revue (pink form) - Girls /& Boys (blue form) - (sent in preentry packet) must be completed and ready to submit to the judge for EACH outfit, on July 10<sup>th</sup>, if you are enrolled in Buymanship. It is structured to help you if you are selected to advance to the State Fair level.

**Construction Garments Revue (green form sent in pre-entry packet)** must be completed and ready to submit to the judge, on July  $10^{th}$ , if you are enrolled in Clothing Construction. It is structured to help you if you are selected to advance to the State Fair level. Attach fabric swatches to this form and attach 4-H Clothing tags to your garments. You will only be judged on modeling on Mon. July  $10^{th}$  and actual construction by consultation on Sat. July  $15^{th}$  - 9:00 a.m. at the fair. (consultation schedule mailed at later date)

**Cost per Wear** - *Suggestion:* When using cost per wear, use 5 as the minimum number of times to wear an outfit. Know how much it is costing you each time you wear it.

**Please remember to be on time** for your scheduled judging times on Monday, July 10<sup>th</sup>. All forms are on the web at <a href="www.hodgeman.ksu.edu">www.hodgeman.ksu.edu</a> on the 4-H & Youth page. Please be sure to bring your scripts & Revue/Cost per Wear (on the back) forms to hand to the judges.
